At present, the Marston Vale Line line speed is painfully slow, making driving the much more efficient method of transport. This, in part, owes to the sluggish nature of the line in terms of pre-1960s small village halt-style stations. In the 21st

century we must consider whether maintaining these stations in small villages and hamlets is realistic, and build more effective, better-served stations in higher population areas, which also maintain park and ride facilities for users of closed stations. This approach will deliver better for the local economy between Bletchley and Bedford than maintaining the status-quo of keeping these other minor stations open.

We are in significant support of fully electrifying East West Rail from the outset and providing passive provision for OLE if this is not possible in the immediate short-term future.

In line with our 2050 Vision (https://enroutecic.com/2050vision/rail-infrastructure) we'd like to see the following service frequencies at EWR's new stations, if not this, exceeded:

For settlements of over 8,000, a minimum of 1tph towards a major settlement with other connecting services.

For settlements of over 25,000, a minimum of 2tph towards a major settlement with other connecting services.

For settlements of over 50,000, a minimum of 4tph towards a major settlement with other connecting services.

We define a major settlement with other connecting services as a town or city with a population of over 150,000, with direct rail links to London, Birmingham and Manchester.

For example, for those living in Bow Brickhill (with a nearby population of around 14,000), we'd expect at least 1 train per hour direct to either Milton Keynes Central or Cambridge, where passengers can also change for trains to London and Birmingham.
